Notes from IT

Composing an Effective Help Desk Request

The Help Desk is dedicated to assisting you in your daily tasks. From issues with report printing and computer login troubles to difficulties connecting your laptop to a projector – we are readily available to provide support.

Consider these suggestions to expedite the assistance we provide to you.

Write a Descriptive Summary

Use wording in the subject field of your email that states what the specific problem is and what you are seeing.

Examples of descriptive summaries:

- Cannot log in to the computer. Says the account is locked.
- Speakers are not working in the courtroom.
- The phone is not working in the front lobby.
- I cannot access Justin's calendar today. It worked yesterday.
- Website X is loading very slowly. Others seem to be working.

Put Details In The Email Body

In the body of the email include all pertinent information related to the issue, such as the room where it is happening, the specific computer, printer, desk, projector, etc., and the time of the occurrence. Providing any relevant details you are aware of will enable our team to address the problem more efficiently.

Try to include:

- What you were doing when the problem happened?
- When was the last time this worked (if ever)?
- Does this happen every time you do X?
- When did you first notice this?
- What was supposed to happen, but didn't?

It's a good idea to include your contact information such as your email or phone number so we can reach you. Having the information ready makes it easier for the help desk team to contact you.

Following Up On A Ticket

“My ticket has been open for three days and no one has contacted me yet.”

Often times we try to contact the ticket creator by email or voicemail and wait to hear back about a clarification. A good way to follow up on your ticket is to email us with the ticket number. Creating a new help desk ticket requesting an update to another help desk ticket will take extra time for the team member to look up the information.
