



## Open Enrollment Taking Place Now Through June 23

The open enrollment period for employee benefits is currently taking place and will close at **5 p.m. on June 23**.

Plan changes to begin July 1:

- 10% increase in non-wellness plan rates
- HSA deductible increased to \$1500/3000 per state mandates
- County contribution to the HSA will increase to \$1300

Employees who participate in the FSA and wish to continue must re-sign up.


