
SeeClickFix Access Oconee GA

Cybersecurity Tips for Tax Season

During tax season, it's important to emphasize the importance of cybersecurity. The increase in online tax submissions has been matched by a rise in cyber threats. Below are essential cybersecurity tips to ensure your tax submission process is secure and your personal information is protected.

Use Trusted Tax Preparation Services

Ensure you're using a reputable tax preparation service. Look for services that offer strong security measures, such as two-factor authentication (2FA). Services endorsed by the IRS through the Free File Alliance are typically reliable.

Secure Your Internet Connection

When submitting your taxes, use a secure, private internet connection. Public Wi-Fi networks can be breeding grounds for cyber threats. If you must use public Wi-Fi, consider employing a Virtual Private Network (VPN) to encrypt your connection.

Protect Your Personal Information

Be cautious about sharing personal information. Tax season is a golden opportunity for phishing attempts. Remember, the IRS will not contact you via email, text, or social media for personal or financial information. Any such communication should be considered a red flag.

Regularly Update Your Software

Ensure your computer's operating system and any tax-related software are up to date. Cyber attackers frequently exploit vulnerabilities in software, and updates are crucial for patching security holes.

Use Strong Passwords and Enable 2FA

Create strong, unique passwords for each of your accounts, especially those related to tax filing and financial information. Enabling two-factor authentication adds an extra layer of security.

Monitor Your Accounts

Regularly check your financial accounts and credit report for any unusual activity. Early detection of fraud can significantly minimize damage.

Securely Store or Dispose of Tax Documents

Digital tax documents should be stored in a secure location, such as an encrypted folder. Physical documents should be kept in a safe place. If you need to dispose of any tax documents, make sure to shred them thoroughly.

Know How to Report Identity Theft

If you suspect you've been a victim of tax-related identity theft, respond immediately. Contact the IRS and file a report with the Federal Trade Commission (FTC) at [IdentityTheft.gov](https://www.IdentityTheft.gov).

While the digital age brings convenience to our tax submission process, it also requires us to be more vigilant about cybersecurity. By following these tips, you can protect yourself from becoming a victim of cybercrime this tax season.
