PARK RULES & REGULATIONS

GENERAL PARK RULES & REGULATIONS

- Use of park permitted during authorized operational hours only.
- Field and group reservations must be made in advance.
- Tobacco Free Parks - Tobacco use is not permitted in the parks.
- Alcoholic beverages and/or drugs are not allowed on park premises.
- Loud, profane and/or abusive language or conduct is prohibited.
- Pets must be controlled on a leash no greater than 6 feet. Owners are required to clean up their pet's waste.
- Glass beverage containers are not permitted on park grounds.
- Vehicle traffic permitted in designated areas only.
- Usage of hoverboards, skateboards, bicycles, scooters, rollerblades and other similar items should be limited to locations that do not have vehicular traffic, pedestrians walking/running, or spectator areas.
- Multi-use paved trails are available for use by pedestrians, bicyclists, and any non-motorized modes of transportation.
- Electric mobility devices are permitted for use only by persons with mobility-related disabilities.
- Litter must be disposed of properly in proper trash receptacles.
- Private training for pay is not permitted on park property.
- The use of public parks for private profit-making business or individual is prohibited, with the exception of county co-sponsored events and non-profit civic organization fundraising.
- Park staff is responsible for turning sports field lights on and off.
- Use of any special equipment (tents, moonwalks, sound, etc.) must receive prior written approval.
- No person shall mark, vandalize, displace or remove any structure, equipment or other park property.
- Children must be under adult supervision.
- No hitting, kicking, throwing or batting balls into fence or building.
- Grills at the pavilions are available for park users. Coals are to be left in the grill, not placed on the ground or into trash receptacles.
- Charcoal fires are allowed only in the park provided grills unless person has received prior written approval. No grills are permitted on pavement and/or asphalt areas.
- Propane grills are not permitted in parks.
- Under no circumstances are signs to be nailed, pinned, or stapled to any shelter, tree or park signs.
- No rental request shall be granted that is not under the direct supervision of an adult.
- No event shall promote and/or advertise tobacco or alcohol related entities.
- Renter shall not demonstrate discrimination in regards to race, age, religion, sex, nationality, political belief or affiliation, veteran status or physical ability.
- Overnight camping is not permitted without preapproval.
- Fireworks are prohibited in all the parks.
- Solicitation and/or posting of bills are prohibited on park property.
- Failure to comply with Park Rules and Regulations may result in denial of future park usage.

INDOOR FACILITIES RULES & REGULATIONS:

- Animals are not allowed inside facilities, except canine companions.
- Bicycles, rollerblades, skateboards or similar items are not allowed inside facilities.
- Candles, portable heaters and/or smoke machines are prohibited inside facilities.
- No smoking or other tobacco products are permitted in any indoor facility.
- Indoor facility capacity must adhere to seating and standing Fire Code restrictions.
- Darken lighting must be pre-approved for safety reasons.
- No food or drinks allowed inside the gymnasium.
- No items or substance may be placed on the gymnasium floors.
- Only tennis shoes allowed on gymnasium floors.
