

## HAS THE SCHOOL SYSTEM SENT YOU TO THE COURT FOR PAPERWORK TO ENROLL A STUDENT ?

### READ THIS FIRST BEFORE YOU PROCEED

In most cases, individuals are informed by school personnel to go to the Probate Court to get a letter from the court in order to enroll a student into the school system. The letter that is referred to is called a "Temporary Letter of Guardianship of a Minor".

In order to obtain such a letter, the individual seeking the letter must file a petition with this court requesting to be appointed as the temporary guardian of the minor. As part of the petition, the natural mother and father of the minor, must first sign a legal document temporarily relinquishing their parental rights of the minor. Once these documents are signed and filed with the court, the court can then proceed with the process for appointment of the petitioner to become the legal temporary guardian of the minor. Once a guardianship of the minor is established, it remains in place until the parents petition to terminate the guardianship or until the minor reaches the age of eighteen, whichever occurs first.

**As you can see, this process is not for the purpose of enrolling a student in the school system, but it is a legal action to provide for the appointment of a temporary guardian when a minor's natural mother and father have relinquished their parental rights of the minor.**

**TEMPORARY GUARDIANSHIPS OF MINOR(S)**  
**General Information and Instructions**

**Please do not attempt to fill in any of the forms until you read this information sheet, attached documents and petition.** The Court will not accept your petition if the paperwork itself is in bad condition (i.e. wrinkled, stained, ripped, etc.) If the petition is illegible or sloppily written with key information crossed through or completed incorrectly, your petition will not be accepted for filing.

This Court will not grant Temporary Letters of Guardianship from one custodial parent to another. A custody change or temporary agreement must be filed in the appropriate Court having jurisdiction.

The petitioner(s) (*the person filing the petition and requesting guardianship of the minor*) and anyone over eighteen years old living in the same household where the child will be living must fill out and sign a consent form allowing the Probate Court to receive any information obtained concerning their criminal records. Signatures on the consent form must be signed in front of a Probate Clerk. They will make a copy and the petitioner will take the consent form to the Oconee County Sheriffs' Department. The consent form is included in this packet.

Neatly complete pages 1 through 7 of the Petition before returning the same to the Court. Carefully read paragraph 4 to verify that the correct choice is initialed by the petitioner (**only one choice, a, b, or c should be initialed**). Make sure the blanks on page 6, the Acknowledgement and Consent to Creation of Temporary Guardianship, are filled in properly **BEFORE** the parents sign this page. Where indicated, the petition must be signed in the presence of a notary public or a Probate Court Clerk and the appropriate seal affixed. Proper identification of the person(s) signing the document must be provided.

Notice of the Petition must be given to both parents of the minor child, including the biological father, even if his name was not listed on the birth certificate. Please see paragraph 2 of the "Instructions" page for further explanation of "parents" and "natural parents". If either parent does not sign the Acknowledgement and Consent to Creation of Temporary Guardianship, page 6, they must be served by one of the following methods: (1) personal service by the Sheriff if they reside in Georgia at a known address, (2) first class mail if residing outside of Georgia at a known address, or (3) publication in the local paper for 2 weeks if current address is unknown. **Additional fees will apply for sheriff's service or publication.**

CERTAIN RESPONSIBILITIES OF THE GUARDIAN OF A STUDENT

1.

A student must live full-time with the guardian in order to be eligible to attend school.

2.

The guardian is responsible for the enrollment and attendance of a student.

3.

The guardian is responsible for any financial obligations which might be incurred by the student at school.

4.

The guardian is responsible for establishing and maintaining all normal relationships between the school and the home, i.e., attending conferences, signing reports, excuses, etc., working with the school on academic progress and conduct.

5.

The guardian is responsible for notifying the school in the event the guardian moves within or outside the county or if a guardianship of the student is ever terminated.

GENERAL INFORMATION

1.

The Probate Court may notify the school system in the event the guardianship of the student is terminated.

From time to time officials of the school system may verify the residence of the student.

**PETITION FOR TEMPORARY LETTERS OF GUARDIANSHIP OF MINOR**  
**INSTRUCTIONS**

**I. Specific Instructions**

1. This form is to be used for filing a Petition for Temporary Letters of Guardianship of a Minor pursuant to O.C.G.A. § 29-2-5.
2. Notice of the Petition must be given to the “parents” of the Minor. If an objection to the establishment of the temporary guardianship is filed by a parent who is also a “natural guardian,” the Court will dismiss the Petition without a hearing. If a parent who is not a natural guardian objects, a hearing on the matter will be scheduled.

A “parent” is defined as the biological or adoptive father or mother whose parental rights have not been surrendered or terminated. However, in the case of a child born out of wedlock, the Father shall be considered a “parent” only if he has legitimated the Minor.

A father of a child born out of wedlock has legitimated the Minor if he married the Mother after the child’s birth or obtained an order of legitimation from a court of competent jurisdiction.

A “natural guardian” is defined as each parent, unless the parents are divorced. If one parent has sole legal custody, that parent is the sole “natural guardian.” If both parents have joint legal custody, then both parents are the “natural guardians.”

3. Although a mother or father may not be a “legal parent,” the Court may require service on such person.
4. A temporary guardianship will be deemed to be a permanent guardianship for the purposes of obtaining medical insurance coverage for the Minor if the guardian assumes in writing the obligation to support the Minor while the guardianship is in effect to the extent that no other sources of support are available.
5. Unless otherwise permitted by the Probate Court in which the Petition is filed, a separate Petition must be filed for each minor. Contact the Probate Court in which the Petition will be filed for its policy. If the filing of one Petition for more than one minor is permitted by the Probate Court, modify the Petition accordingly.
6. According to Uniform Probate Court Rule 5.6 (A), unless the Court specifically assumes the responsibility, it is the responsibility of the moving party to prepare the proper citation and deliver it properly so it can be served according to law. All pages after the Notice regarding Uniform Probate Court Rule 5.6 (A) are to be completed by the moving party, unless otherwise directed by the Court.



7. O.C.G.A. § 53-11-2 provides that a party to a probate proceeding who is not sui juris must be represented by a guardian provided that the Court may appoint a guardian ad litem or determine that the natural guardian, guardian, conservator or testamentary guardian has no conflict and may serve. Should a guardian ad litem be necessary because a party is not sui juris, use Supplement 1.
8. Use Supplement 2 if the Court determines it is necessary to appoint a special process server.
9. Use Supplement 3 when an additional certificate of service is necessary.
10. Exhibits should be labeled at the bottom of each exhibit as Exhibit "A," Exhibit "B," etc. in consecutive order. The corresponding letter of each said exhibit should be inserted into the appropriate place in the form.
11. An oath must be administered by a Probate Judge or Clerk (the oath cannot be administered by a notary public). Use Georgia Probate Court Supplement 4 for the oath. The oath is not included in this form. Georgia Probate Court Standard Form 53, Commission to Administer Oath, can be used if the oath is to be administered by a court outside the State of Georgia.
