All provisions of laws and ordinances governing this type of work will be complied with whether specified herein or not. The granting of a permit does not presume to give authority to violate or cancel the provisions of any other state or local law regulating construction or the performance of construction. This permit must be renewed if the work described above is not started within six (6) months from the date the permit is issued. *I understand that the Swimming Pool Code and Oconee County Ordinances require a 4' fence around the pool that meets the State Swimming Pool Code requirements and must be installed prior to swimming pool being filled with water.*
