**NO SOIL EROSION PERMIT WILL BE ISSUED UNTIL PRELIMINARY PLATS AND ROAD/WATER SYSTEM CONSTRUCTION PLANS  
HAVE BEEN THOUGH DRC MEETING. NO LAND DISTURBING ACTIVITY SHALL BE DONE UNTIL AN APPROVED SOIL EROSION &  
SEDIMENTATION CONTROL PLAN HAS BEEN SECURED. LAND DISTURBING ACTIVITY INCLUDES BUT IS NOT LIMITED TO  
CLEARING, GRADING, EXCAVATING, TRANSPORTING AND FILLING OF LAND. MORE THAN TWO VIOLATIONS OF PREVIOUS  
PERMITS WITHIN THREE YEARS PRIOR TO THE DATE OF FILING APPLICATION SHALL REQUIRE THE ISSUING AUTHORITY OF  
OCONEE COUNTY TO REQUIRE THE APPLICANT TO POST BOND NOT TO EXCEED THE AMOUNT OF \$3,000.000 PER ACRE.**
